The Kalimpong Govt. PTTI at Ringkingpong Road, Chandralok, Kalimpong and Shree Ramakrishna Govt. Sponsored PTTI at Dr. Zakir Hussain Road, Rockvile, Dareeling have been functioning as Primary Teachers' Training Institute for a long time. In case of both of the two districts of Kalimpong and Darjeeling there is no District Institute of Education & Training (DIET) and there should be one DIET in each district as per guidelines of MoE, Govt. of India.

Now, in view of the above, "The Kalimpong Govt. PTTI" is upgraded to function as "District Institute of Education & Training (DIET), Kalimpong" which was already approved by MoE, Govt. of India vide PAB minutes of MHRD, GoI for the Financial Year 2018-2019 and "Shree Ramakrishna Govt. Sponsored PTTI "is upgraded to function as "District Institute of Education & Training (DIET), Darjeeling" which was already approved by MoE, Govt. of India vide PAB minutes of MHRD, GoI for the Financial Year 2012-2013. The existence of PTTIs from those institutes are, therefore, withdrawn and only DIET, Kalimpong and DIET, Darjeeling will function from those campuses and it is also stated that D. El. Ed course spanning over two years and any administrative change in the nature of constitution of those institutes brought about by way of upgradation of the erstwhile PTTIs are not supposed to affect the academic aspect of the existing students in any way. Hence the students who are in the 1st year before upgradation are by default eligible for admission in the 2nd year of the existing course.

It is also notified that the Principals/Sr. Lecturers-in-Charge of the "District Institute of Education & Training (DIET), Kalimpong & Darjeeling" from hence and hereafter will be the "Head of Office" in respect of those said Institutes under sub rule (16A) Rule 5 of the WBSR, Part-I and as "Controlling Officer" in respect of all the officials/staff (academic & administrative) serving in the said Institutes under her/him under sub-rule (5) of Rule 4 of the WBSR Part-II as notified in 978-SE(Pry)/DIET-10/04 dated:31.08.2005.
